### Monroe Capital Corporation Announces Fourth Quarter Distribution of \$0.35 Per Share

CHICAGO, Ill., November 30, 2018 – Monroe Capital Corporation (the "Company") (NASDAQ: MRCC) announced today that its Board of Directors has declared a distribution of \$0.35 per share for the fourth quarter of 2018, payable on December 28, 2018 to stockholders of record as of December 14, 2018. The Company has adopted a dividend reinvestment plan that provides for reinvestment of distributions on behalf of its stockholders, unless a stockholder elects to receive cash prior to the record date. As a result, when the Company declares a cash distribution, stockholders who have not opted out of the dividend reinvestment plan prior to the record date will have their distribution automatically reinvested in additional shares of the Company's capital stock. The specific tax characteristics of the distribution will be reported to stockholders on Form 1099 after the end of the calendar year and in the Company's periodic report filed with the Securities and Exchange Commission.
